


# NEW YORK STATE SEXUAL HARASSMENT PREVENTION TRAINING

As of October 9, 2018, every employer in NYS is required to adopt a sexual harassment prevention policy and must provide employees with annual sexual harassment prevention training prior to October 9, 2019.

## The in-depth training must:

- Include examples of conduct that would constitute unlawful sexual harassment
- Include information concerning employees' rights of redress and all available forums for adjudicating complaints
- Include information addressing conduct by supervisors and any additional responsibilities for such supervisors
- Include information addressing conduct by supervisors and any additional responsibilities for such supervisors
- Be interactive
- Include an explanation of sexual harassment consistent with guidance issued by the Department of Labor in consultation with the Division of Human Rights
- Include information concerning the federal and state statutory provisions concerning sexual harassment and remedies available to victims of sexual harassment
